

## PROGRAM INFORMATION

The **Harris County Sheriff's Office Citizen's Police Academy** was created to provide citizens with a realistic view of the activities and responsibilities of a deputy sheriff.

The **Citizen's Police Academy** is a thirteen(13) week program and the classes are held once a week, with each session lasting approximately three (3) hours. Each block of instruction is taught by experienced law enforcement professionals.

Graduates of the Academy will gain a better understanding of law enforcement and see "how and why" deputies arrive at some of the decisions made in the course of their duties. This also provides the justice system with better informed jurors.

Each Class is composed of a cross section of Harris County's diverse citizenry. Laborers, professionals, students, ministers, civic/social leaders and homemakers are encouraged to apply for enrollment. The minimum age for enrollment is 21 and you must live in Harris County.
